WAIVER OF LIABILITY; ASSUMPTION OF RISK

I hereby acknowledge that the use of Columbia Hills facilities, equipment, services and programs involves an inherent risk of personal injury to the Member and Member's guests. I voluntarily agree to assume all risks of personal injury to the Member, Member's spouse, children, unborn children, other family members and guests and waive any and all claims or actions against Columbia Hills, any parent companies, subsidiaries or other affiliates and any respective officers, directors, employees, insurers, agents and assigns for any such personal injury or illness, including, without limitation, injuries or illness arising from, or from the use of, the golf course, golf carts, swimming pools, games, supervised or unsupervised activities and programs, dining facilities, locker rooms, saunas, showers and dressing rooms.

I shall indemnify Columbia Hills, its parent companies, subsidiaries and affiliates and each of their officers, directors, employees, insurers, agents, successors and assigns and save and hold each of them harmless against any claim that is the subject of the waiver set forth above. The provisions of this paragraph shall survive the termination of this waiver and Member's membership.
